Holiday Guidance

Dear Family and Friends of South Cove Manor:

With the Holidays upon us, I wanted to reach out to everyone and discuss how the current COVID regulations will affect how the holiday can be celebrated. The regulation requiring all visitors to wear a mask while in the building is still in place, and most likely will be for the foreseeable future. As a result, visitors sharing a meal with their loved one is prohibited in resident rooms and in the courtyard.

Residents are allowed to leave the building to spend time with their family. If you would like to take your family member out of the building to enjoy a holiday meal, please let the Unit Manager on the floor know as soon as possible. There are some residents that will need approval from their physician, and our Unit manager will need time to obtain that approval. The Unit Manager will need to know an approximate time you plan to pick up and return the resident, so we can prepare any medications that may be needed during their time away from the building.

While I am not one to advocate living in fear because of the virus, I would ask everyone to keep in mind that if a resident does leave the building, the risk of coming into contact with a COVID positive person is heightened. In addition, if there are, residents should not visit with any friends or any family members that have recently tested positive or are showing signs and symptoms of COVID.

允許居民離開大樓與家人共度時光。如果您想帶您的家人到大樓外享用節日大餐，請盡快告知該樓層的護士長。有些院民需要醫生的批准，而我們的樓層護士長需要時間來獲得批准。樓層護士長需要知道您計劃接送院民的大致時間，以便我們可以準備他們離開大樓期間可能需要的任何藥物。

雖然我不是提倡因病毒而生活在恐懼中的人，但我會請大家記住，如果居民確實離開了大樓，那麼與 COVID 陽性者接觸的風險就會增加。此外，如果有，居民不應拜訪最近測試呈陽性或出現 COVID 跡象和症狀的任何朋友或任何家庭成員。
